

If you purchase the crash damage reduction and pay \$200 per day your liability will be reduced to a maximum of \$3,000 for the first crash and will increase as follows each crash over \$3,000:

Insured DI – Incidents over \$3,000

1 st Crash	\$3,000
2 nd Crash	\$4,000
3 rd Crash	\$5,000
4 th Crash	\$6,000

If you do not purchase the crash damage reduction waiver your liability will be a maximum of \$6,000 for the first crash and will increase as follows each crash over \$1,500:

Uninsured DI – Incidents over \$1,500

1 st Crash	\$6,000
2 nd Crash	\$6,750
3 rd Crash	\$7,500
4 th Crash	\$8,250
5 th Crash	\$9,000

Driver liability will increase \$750.00 US per incident that results from either \$1,500 US damage to a drivers own car or \$1,500 US damage to a competitors car as the results of driver error that involved “significant lack of good judgment”. Maximum liability per incident in the course of a season is \$13,500 US unless Skip Barber *MAZDASPEED* Pro Challenge Officials deem a driver to be unsafe or whose conducts is detrimental to the sport. In the case of a driver being deemed unsafe the maximum per incident liability can be raised to as much as \$42,500 US.

Championship prizes are contingent on the driver having no outstanding damage (or other) invoices. Any outstanding invoices must be paid before season end awards are distributed.

Contingency prizes, if any, are paid directly by the sponsor and are not the responsibility of the Skip Barber Racing School LLC or the Skip Barber Racing School *MAZDASPEED* Pro Challenge.

In order to receive a Skip Barber Racing School *MAZDASPEED* Pro Challenge award the winner must first read and sign the Skip Barber Racing School *MAZDASPEED* Pro Challenge Award Agreement. The full terms of the agreement are available to entrants upon request for inspection on a strictly confidential basis. The purpose of the award and the agreement is to facilitate and promote the winners racing career and also to promote Skip Barber Racing School. The terms of the agreement will include but are not limited to requirements during the award year and subsequent years. Depending on the prize awarded, the winner shall display Skip Barber Racing School approved identification on his/her race car(s), driving suits, helmets, make appearances, provide paid instruction and permit the use of his/her name and images in the Skip Barber Racing School promotions. The agreement will be a formal, binding contract, which must be recognized by subsequent teams or sponsors.
